



## FAQs for Galleri Testing



### What is the Galleri test?

The Galleri test is a multi-cancer early detection test that detects more than **50 types of cancer**, many of which are not commonly screened for today, through a simple blood draw. The Galleri test does not diagnose cancer and not all cancers may be detected in the blood. Additionally, for each type of cancer the Galleri test screens for, there are variable levels of sensitivity for detection, and the sensitivity can change depending on what stage the detected cancer is at the time of testing.



### How does the test detect cancer?

The Galleri test looks for signals present in the blood that may be associated with cancer at the time of your blood draw. If a cancer signal is detected, Galleri results can point to where in the body the cancer is coming from to help your healthcare provider guide next steps.



### Who is recommended to take the Galleri test?

The Galleri test is recommended for use in adults with an elevated risk for cancer, such as those aged 50 or older. Annual testing is recommended, just as annual screening is recommended with the currently available commercial tests with your Primary Care Provider. The Galleri test is intended to be used in addition to, and not replace, other cancer screening tests your healthcare provider recommends.

### Can my family members receive testing also?

### What cancers are considered presumptively connected to fire service, based on workers' compensation law?

According to Title 6, Public Officers and Employees, Chapter 607.055, cancers which originate in the stomach, colon, rectum, skin, prostate, testis, or brain, as well as non-Hodgkin's lymphoma, multiple myeloma, malignant melanoma, and renal cell carcinoma are presumed to have developed during the course and scope of employment as a firefighter or emergency medical technician if:

(1) The firefighter or emergency medical technician:

1. Regularly responded on the scene to calls involving fires or fire fighting; or
2. Regularly responded to an event involving the documented release of radiation or a known or suspected carcinogen while the person was employed as a firefighter or emergency medical technician.

Applicability is limited to those individuals who were employed for **at least five years or more** as a firefighter, peace officer, or emergency medical technician, and for those cancers which are discovered during employment. Presumption is **not automatically granted** to those individuals who were users of tobacco (or if the individual's spouse was a smoker during the marriage) where cancers which are related to tobacco use are diagnosed.

## What Should I Do If A Cancer Signal Is Found?

If a cancer signal is detected, additional testing would be recommended to confirm the finding. Additional testing may include labs, imaging, and a biopsy.
